2013 Alternative Funds Income Dividends and Capital Gain Distributions

Every year, mutual funds must distribute to shareholders any net investment income and net realized capital gains in order to satisfy the requirements of the Internal Revenue Code applicable to mutual funds. The 2013 distributions from our Alternative Funds can be viewed below.

For all of the Alternative Funds' classes of shares, the income dividends and capital gain distributions are payable on December 23 to "shareholders of record" as of December 19. New shares have been purchased for reinvesting shareholders at net asset values at the closing price on December 20.
